CITY HALL BUILDING

With the permission of City Council, the following report of the City Hall Building Committee was introduced after consideration of Clause No. 20 of Report No. 4 of the Board of Control to accommodate the Architects, Messrs. Bland and Trudeau, who had come to Ottawa for the meeting and had to return to Montreal.

Her Worship the Mayor left the Chair, which was assumed by Controller Tardif, and presented the Report of the Ctiy Hall Building Committee.

REPORT OF THE CITY HALL BUILDING COMMITTEE

The Committee recommends to Council that it be authorized to give instructions at once to the Architects, Rother, Bland and Trudeau, to proceed with working drawings for the City Hall as proposed on Green Island.

The Committee reports that immediately following Council's decision on January 30th arrangements were made for the Architects to meet with the Architectural Sub-Committee of the F.D.C. This meeting took place on February 2nd.

Suggestions then made, in a rough sketch, a copy of which is transmitted herewith, were taken up with the Architects by the Architectural Committee of the F.D.C.

The Architects prepared, first the report which is transmitted here as addendum (1) with the suggestions made to the City Hall Building Committee for adaptation of the plans to the Green Island Site.

The Architects then studied the sketch and the letter from the F.D.C. which was transmitted both to Council and to Board of Control, the Board of Control referring the matter at once to the City Hall Building Committee.

As addendum (2) there is attached hereto the report of the Architects in respect to these proposed changes.

Dear Sir:

In accordance with the Council's request, we have carefully studied all the factors involved in the change of site from City Hall Square to Green Island.

Consideration has been given in our study to the physical features of the site as well as to the interests of the Public, the Federal District Commission and the City Administration.

We are pleased, therefore, to advise as follows:

- 1. No change of plan from the ground to 7th floor inclusive is proposed or required as a result of the change of site.
- 2. Modifications affecting the basement and penthouse space only are based on:
 - (a) The sub-soil conditions of the site. It is considered advisable to minimize construction below ground to avoid costly water-proofing problems.
 - (b) location of the building to provide proper relationships with the main approaches, other public buildings and the island site.
 - (c) the provision of a slight increase in the mass of the building to obtain decisive contrast with the National Research Council Building.

These modifications do not involve any change in the estimated cost of the new City Hall.

Modifications:

1. Omission of the Sub-Basement.

All parking for the required 160 cars would now be provided on one floor, the lower ground floor, which would be approximately at the existing ground level of the island.

This modification will reduce excavation and avoid the waterproofing problem. It is made possible by the difference of level between Sussex Street and the island.

The slab above the lower ground floor (as in the original plan) forms the paved platform on which the building stands at the correct level in relation to Sussex Street to maintain the fine approach to the building.

The increased setback of the building from Sussex Street, which is necessary to give the building its proper relationship to the approaches, etc., provides the additional area at the lower ground floor required for the one-floor parking.

2. Extension of the penthouse area to accommodate all mechanical and heating equipment and storage, previously accommodated in the sub-basement.

Modern practice makes it possible to operate oil-fired equipment efficiently from the top of the building as well as from the basement area. There are many large buildings in the United States and Canada designed in this way, where the basement is unsuitable for one reason or another. In this particular case considerable expense would be avoided in excavation and waterproofing. The slightly greater building mass obtained by this extension is desirable to provide decisive contrast with the National Research Council Building.

3. Cost analysis based on cubic content.

This analysis shows a reduction of 160,644 cu. ft. in the cubic content of the building with the modified plan, without sacrificing any of the accommodation provided in the original plans.

This reduction in cube would be roughly offset by the increased area of paving at ground floor level and an increase in certain structural and finishing elements.

It is considered, therefore, that on this basis there should be no increase in the estimated cost of the City Hall as modified for the Green Island Site.

It is suggested that with the new site, consideration might be given to the provision of a lounge on the penthouse floor which could be accommodated without further increase in the cube of the building. Commanding views across the Ottawa River and a fine space for the entertainment of important visitors would thus be obtained.

We should like to add that, on the basis of our study, and having regard to the function of the building, we are of the opinion that the plan and design for the new City Hall as accepted for the City Hall Square site, subject to the above modifications, is eminently suited to the Green Island site and would provide an impressive City Hall on a fine park site.

Finally, this plan and design, on the Green Island site, will permit future extension of the City Hall without interference with the design, appearance or functioning of the building, and without addition to the present estimated cost of the building.

It is the hope of Board of Control that all these references may be expedited to the end that any further comment or suggestions may be available before the March meeting of the F.D.C.

Re: City Hall Plans

Dear Sir:

As requested by the City of Ottawa, the competition plans for the proposed new City Hall were thoroughly studied by the Architectural Committee of the Federal District Commission and discussed with Messrs. Bland, Rother and Trudeau, of Montreal, the architects who prepared them.

The Committee considered that the City Hall design was not the type of design which would have evolved had it been designed for Green Island. It felt that the importance of the site and building warranted a much higher structure and recommended that the city height by-law be amended to accommodate such an increase in height. The Committee considered that a building constructed to the competition drawings, when viewed from the Quebec shore, would appear insignificant compared to the scale of the waterfall and Ottawa River cliffs. On the other hand, a dignified building with a high

shaft on this site would be the most dominant feature of this section of Ottawa, which the Committee felt should be the function of this building.

With regard to the location on the site itself, the Committee felt that the long axis of the shaft should be located parallel to the length of the Island and did not have to be centred on it.

You will appreciate that the recommendations of the Architectural Committee have to be endorsed by the Federal District Commission at a regular meeting and accordingly, we are forwarding these particulars to you at this time, purely for information.


We have had the opportunity to study the Green Island site and to consider the suggestions of the Architectural Committee of the Federal District Commission as proposed to us at their meeting of 2nd February, 1956.

In our study we have considered the characteristics of the site, the approaches, the relationship to other buildings and natural features in the area and to the City of Ottawa, as these relate to the City Hall design.

An analysis of Green Island shows that this site is similar to the City Hall Square site in major respects. Both are "island" sites and have the the same relationship to their main approaches, Sussex Drive and Elgin Street. Gradients on both sites are similar, as would be the views of the building from the surrounding areas.

The differences between the two sites are mainly those of location and sub-soil conditions, and in our opinion are easily resolved by slight modifications to the existing design. These modifications consist of omitting the sub-basement and extending the penthouse to accommodate additional equipment and to provide a slightly greater building mass.

With these modifications the scale of the City Hall is well related to the size of the island and provides decisive contrast with the National Research Council. Its recommended location on the site maintains the character of



the island and gives great significance to the City Hall from its main approach along Sussex Drive.

The actual accommodation of the building is not changed as a result of change of site. The arrangements are considered to be convenient and well suited to the needs of the City Administration, and it is fortunate that the general layout of the building can be maintained.

Finally, as befits its civic character, the City Hall on this site makes an imposing composition dominating its immediate area.

We are able to say, therefore, that the building as designed for City Hall Square, with minor modifications, is eminently suited to the Green Island site. Moreover, Green Island as an alternative was made known to the competitors in Bulletin No. 3 during the competition.

The Architectural Committee of the Federal District Commission felt the importance of the site and building warranted a much higher structure and recommended that the city height by-law be amended to accommodate the necessary increase in height, adding that a building constructed according to the competition drawings would be insignificant when viewed from the Quebec shore. To illustrate this point the Committee gave us a sketch which shows a building of about 20 floors in height.

In our opinion such a building stretches the accommodation requirements over too many floors and would be quite inconvenient departmentally. Furthermore, apart from the increase in initial cost, such a height would add considerably to the cost of maintenance.

We feel that such a tall building would be out of scale with its surroundings when viewed from its main approaches and unnecessarily prominent when viewed from a distance.

We enclose a sketch based on photographs which we had taken from the Quebec side, showing that the City Hall as now modified maintains its significance at a distance.

The National Capital Plan Report proposed a uniform skyline on Sussex Drive in relation to which the mass of the proposed City Hall would be an effective contrast. In our opinion such a contrast would amply assure the . 1956.



We feel, therefore, that the proposed City Hall as modified meets the suggestions, in principle, of the Committee and maintains a general composition that was found to be superior to a wide variety of other solutions to the problem.

To authorize the construction of sanitary sewers and house connections in Rockingham, Gloria, Bavlie, and Brule Avenues as local improvements upon petition.

To authorize the construction of water mains in Denbury, Mayview, Centre, Young, Westhill, Faircrest, King, Cabot, Leslie and Sproule Streets as local improvements upon petition.

The following by-laws received three readings and were passed:

To authorize the execution of various agreements.

To amend By-law 238-55 (Zoning North Carling Area).

To authorize the expropriation of lands for Carling Avenue Widening.

To declare partial exemption of taxes on certain farm lands.

To appoint and fix salaries of certain employees.

To fix the times for making assessments for 1956.

To declare desirability of constructing a water main on Carling Avenue as a local improvement under Section 8.

To declare desirability of constructing water mains on Cummings, Wilson, Clarke, Quebec, Burn and Clyde, as local improvements under Section 8.

To amend By-law 260-51 re Traffic.

To amend certain zoning by-laws re Maximum height of buildings.

The following by-law received a third reading only and was passed:

To authorize the construction of an access road on Borthwick Ave. as a local improvement upon petition. (First and second readings on May 30th, 1955.)
